

2017 ROBERT V. KILLION SCHOLARSHIP BULLETIN

OBJECTIVE

The objective of the Robert V. Killion Scholarship Fund is to assist an individual who desires to further his/her education and acquire the knowledge and skills to be better prepared to participate in future employment. A \$1,000 Scholarship will be awarded to a qualified student from Idaho, Montana or Wyoming. The fund was created to honor USDA - Rural Utilities Service Field Representative Robert V. Killion who passed away November 1, 2001 in a logging accident. The Rural Telco's in Idaho, Montana, and Wyoming created the Robert V. Killion Scholarship Fund.

SELECTION

Selection for the Scholarship Award will be based on these factors:

1. Grades in high school and/or continuing college/technical school grades.
2. Leadership qualities and character.
3. Community and other outside activities.

The successful applicants will be advised of selection and the method of payment by mid May. This will be done by the 3 Rivers Communications Executive Assistant.

ELIGIBILITY

1. Applicants must be a relative of an owner, board of director, manager, or employee of a WTA Member Company in Idaho, Montana or Wyoming in good standing. "RELATIVES" are sons, daughters, grandchildren, and stepchildren (including legal guardian or adopted status).
2. Applicants should be in the graduating class or have graduated from an accredited public, parochial, or private high school.
3. Applicants must be entering or be enrolled in an accredited junior college, technical school, four year college or university.
4. Past recipients of this scholarship are not eligible.

PROCEDURE

1. Applicant must complete and sign the application form.
2. Provide a copy of current transcripts with cumulative grade point average.
3. Provide two (2) letters of recommendation, one being from a school official.
4. Provide a personal statement.
